No substituting except for the same breed and class. No added classes. An entry fee of \$1.00 per head will be charged. No does and litters. Meat pens and single fryers may be entered. Coops will be furnished by the Fair Board. We will not be responsible for loss by fire or theft. However, all precautions will be taken and police will be on duty both day and night.

DISPLAYS - Under Pen of 3Meat rabbits, entry fee per pen is "\$3." The following information should have been added: Does and litters may be entered. Litters must be at least five weeks old. Entry Fee: \$3.00

Single Fryer Class, entry fee is "\$2." Roasters & STewers may also be entered with a \$2.00 entry fee.

All rabbits in Tuesday's caged show must stay for the week of the fair (Aug. 7-13)

This is an ARBA sanctioned show – Not all breeds specialty sanctioned.

Open class cooped rabbits after 1 p.m. Sunday

Judging is Tuesday at 9:00 a.m. Diseased stock will not be accepted – All rabbits must be in class properly ear marked. Note: feed donated by Kalmbachfeeds, Inc.

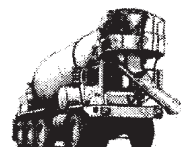

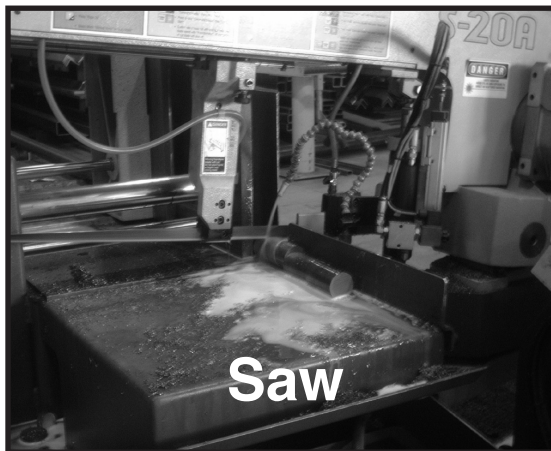
